

# **Hatton Sports Club**

## **Privacy Notice**

**25 May 2018**

## **What we need**

Hatton Sports Club will be the "controller" of the personal information that you provide on the membership form.

When you register as a member of Hatton Sports Club or renew your membership (including if you are registering or renewing on behalf of a child under the age of 18), we will ask you for the following personal information:

- contact details – name, address, email address and phone number. Date of birth only if you are eligible for age-related reduced subscription rates;
- participation details – which sports you play / non-playing member.

## **Why we need your personal information – contractual purposes**

We need to collect our members' personal information so that we can manage your membership. We will use our members' personal information to:

- provide you with core member services, including insurance;
- send you membership communications by email in relation to essential membership services, including but not limited to, general meeting notices and membership renewals.

If you do not provide us with all of the personal information that we need to collect, this may affect our ability to offer the above membership services and benefits.

## **Why we need your personal information – legitimate purposes**

We also process our members' personal information in pursuit of our legitimate interests to:

- promote and encourage participation in tennis, padel tennis, squash and racketball by sending members' communications and booking information for upcoming competitions and events. Our competitions and events may be filmed or photographed and your personal information may also be used in images captured from our competitions and events, which we use for promotional, education and development purposes. We will comply with the terms of our safeguarding policy which states that prior consent is required before children and vulnerable adults can be photographed;
- provide competition in tennis, padel tennis, squash and racketball by accepting and managing entries for our competitions and checking your personal information to ensure you are entered into the correct category;

- develop and maintain our members' qualifications, including sending email communications to members to inform you of upcoming courses, renewal requirements and verify that you have completed any mandatory training and PVG / child protection requirements;
- respond to and communicate with members regarding your questions, comments, support needs, complaints, concerns or allegations in relation to tennis, padel tennis, squash and racketball.

Where we process your personal information in pursuit of our legitimate interests, you have the right to object to us using your personal information for the above purposes. If you wish to object to any of the above processing, please contact us on [hattonsec@gmail.com](mailto:hattonsec@gmail.com). If we agree and comply with your objection, this may affect our ability to undertake the tasks above for the benefit of you as a member.

## **Why we need your personal information – legal obligations**

We are under a legal obligation to process certain personal information relating to our members for the purposes of complying with our obligations under:

- the Protection of Vulnerable Groups (Scotland) Act 2007 to check that our coaches and volunteers are able to undertake regulated work with children and vulnerable adults.

## **Other uses of your personal information**

We may ask you if we can process your personal information for additional purposes. Where we do so, we will provide you with an additional privacy notice with information on how we will use your information for these additional purposes.

## **Sharing your personal information**

We may be required to share personal information with statutory or regulatory authorities and organisations to comply with statutory obligations.

Such organisations include the Health & Safety Executive, Disclosure Scotland, and Police Scotland for the purposes of safeguarding children and vulnerable adults.

We may also share personal information with our professional and legal advisors for the purposes of taking advice.

As an affiliated club of Scottish Squash we are required to share some personal information of our squash-playing members with Scottish Squash. Their privacy notice explains how they use your personal information. It can be accessed by selecting "Privacy Notice - For Members" at [SSL policies](#). ## How we protect your personal information

Your personal information is stored on our electronic filing system. Our server is based in the UK and is accessed by members of the Management Committee for the purposes set out above.

## How long we keep your personal information

We will keep your personal information only for as long as necessary to provide you with membership services. Unless you ask us not to, we will review and possibly delete your personal information where you have not renewed your membership with us for six years.

## Your rights

You can exercise any of the following rights by writing to us at [hattonsec@gmail.com](mailto:hattonsec@gmail.com).

Your rights in relation to your personal information are:

- you have a right to request access to the personal information that we hold about you by making a "subject access request";
- if you believe that any of your personal information is inaccurate or incomplete, you have a right to request that we correct or complete your personal information;
- you have a right to request that we restrict the processing of your personal information for specific purposes;
- if you wish us to delete your personal information, you may request that we do so.

Any requests received by Hatton Sports Club will be considered under applicable data protection legislation. If you remain dissatisfied, you have a right to raise a complaint with the Information Commissioner's Office at [www.ico.org.uk](http://www.ico.org.uk).
